Greetings,

Community Health Centers, Inc. (CHC) has had another great year for our patients. We are pleased to provide details in this annual report about our work and the many patients who benefited from our quality affordable healthcare. Our focus is on helping the uninsured, underinsured, and underserved in Orange and Lake County.

Our patients' health and well being remained our top priority. During this reporting period our 346 dedicated staff members in 11 centers served 50,726 unduplicated patients for 168,120 visits (140,235 medical, 25,486 dental, and 2,399 enabling). Prescriptions dispensed to our patients were 111,776. Of our 50,726 patients, 57% were at or below 100% of the federal poverty level and 45% were uninsured.

CHC continued being one of the top community health programs in the country because of our staff and sound management. Along with several quality improvements with clinical measurements, customer service, and outreach, a few other highlights were:

- The incredible new Apopka Dental Care Center completed and open to patients;
- The ground breaking and initial construction of the new South Lake facility;
- Initial work for serving patients in Bithlo and Meadow Woods ("Medical City" area);
- First Federally Qualified Health Center (FQHC) in U.S. to fully integrate dental electronic health records with medical and pharmaceutical services; and,
- July 2010 CHC received a three year accreditation from the Accreditation Association of Ambulatory Health Care (AAAHC)

Our volunteer 14-person Board of Directors was composed of 54% consumers of our services. The Board's role included providing essential governance and balancing limited resources with the increased special health needs of our community.

CHC remains grateful to our many funding agencies, friends, partners, sponsors, and volunteers who enhanced our ability to serve our patients. We continue to work toward the vision that one day all Central Florida residents shall have access to timely, affordable, compassionate, and quality health services.

New Apopka Dental Care Center Ground Breaking and Ribbon Cutting Ceremonies

CHC has been providing dental services to the Apopka community at the Apopka Family Health Center since 1979. With the support of an American Recovery and Reinvestment Act (ARRA), Capital Improvement Program Grant in the amount of \$990,756 from the U.S. Department of Health & Human Services, Health Resources & Services Administration, CHC began building a new Apopka Dental Care Center on March 24, 2010, and on January 24, 2011 we celebrated the opening of the new dental center building with a Ribbon Cutting Ceremony. The Dental Care Center provides adult dental care and new pediatric dental services. We increased the dental operatories from 4 to 11, increased dental staff, and improved patient access to quality and affordable dental services with the new Dental Care building!

New South Lake Family, Pediatric & Dental Care Center Ground Breaking Ceremony

CHC has been providing medical, dental and pharmaceutical services to the South Lake community since 1978. A Ground Breaking Ceremony was conducted on Thursday, May 13, 2010 for a new South Lake Care Center to be built and replace the existing South Lake Family Health Center located in Groveland, FL. CHC received a \$1.5 million Rural Development Community Facilities Guaranteed Loan and a \$500,000 Community Facilities Direct Loan from the U.S. Department of Agriculture, Rural Development to help build this new \$2.6 million dollar South Lake facility. The new 13,600 sq. ft. center will replace the current 9,450 sq. ft. facility. Patient access to services will not be compromised, as the existing South Lake Family Health Center will continue to stay operational during the construction phase. Upon completion of the new building scheduled for April 2011, the old building will be demolished. This new center will provide expanded Family Practice care and Adult Dental care, and provide new Pediatric and Pediatric Dental care services.

During the year significant Outreach efforts are made to increase community awareness of our services.

Soccer Health Cup Tournament

CHC co-sponsored a two day Soccer Health Cup tournament on May 29-30, 2010, at Thunder Field. We reached out to 550 people by distributing CHC brochures and educational materials.

Amway Arena Back to School Bash

CHC participated in the Amway Arena Back to School Bash on Saturday, August 14, 2010. Over 10,000 children attended this event, receiving free Back Packs full of school supplies. CHC had a booth at the event providing Free Health Screenings for Adults and Free Dental Screenings for Children. CHC provided 427 children with a free dental screening, 129 adults received a Glucose screening, 125 adults received Blood Pressure checks, and 85 adults received Cholesterol screenings.

8th Annual Caribbean Health Summit

CHC participated in the Center for Multicultural Wellness and Prevention's 8th Annual Caribbean Health Summit held on Saturday, September 11, 2010 providing free Blood Pressure & Glucose Screenings to hundreds of uninsured and underinsured individuals.

Christmas Parade

We took part in the Foliage Sertoma Club of Apopka's 34th Annual Christmas Parade on Saturday, December 11, 2010. Our float's theme was "Community Health Centers will be your medical home for Christmas and all year long!" Child toothbrushes, Silly Bandz, and Bandaid holders were handed to the crowd.

Accreditation

In July of 2010 Community Health Centers received a three year accreditation from the Accreditation Association of Ambulatory Health Care. Status as an accredited organization means that Community Health Centers has passed a series of rigorous and nationally recognized standards for the provision of quality health care. Accreditation underscores our ongoing commitment to providing the highest possible level of quality care to the communities we serve.

Electronic Health Records

In 2009, Community Health Centers completed the process of enhancing its technology infrastructure by successfully implementing an Electronic Health Record System (EHRS) at all medical locations. In 2010 CHC implemented the Electronic Health Record System at all dental locations and became the first practice in the nation with an integrated medical, dental and pharmaceutical Electronic Health Record System. The EHRS has enhanced the quality of care provided by permitting information exchange among providers, computerized order entry for prescriptions, labs, and procedures, enhanced legibility of clinical documentation and preventive health patient tracking and notifications.

Pediatrics

Community Health Centers child immunization rates continue to exceed the national average of 80%. Many of CHC's facilities have received the Gold Certificate of Superior Achievement Award from the Florida Department of Health, Bureau of Immunizations, for providing immunization coverage to 98% of their pediatric patients. Additionally, 96% of children ages three and under received testing for elevated blood lead levels.

Chronic Disease Management

Community Health Centers established a patient advocate program to provide care coordination, management and counseling for patients with chronic conditions or other complex health issues.

Additionally, 73% of patients with a diagnosis of diabetes are controlled, with A1C levels less than 9% and nearly 60% of patients with a diagnosis of hypertension have blood pressures less than 140/90, which reduces the probability of the development of secondary complications in the patient population.

Employee and Patient Satisfaction

CHC embarked upon a continuous journey towards a commitment to service excellence with the goal to increase the satisfaction of our patients and employees. All staff at CHC were provided the opportunity to provide feedback via an employee engagement survey which resulted in the revamping of processes to improve the overall satisfaction for our staff. A Customer Service Committee was developed with staff from multiple disciplines to identify the customer service needs of the organization and to develop processes and procedures for improving overall customer service. Additionally, every staff member in the organization received a 4 hour training in Customer Service.

In the summer of 2010, CHC had an event to highlight its customer service initiative to its patients, Board members and visitors. Each staff member signed a pledge committing to customer service, posters were hung at each site communicating the standards of customer service conduct within the organization along with customer service communication boards and score thermometers.

Services

Adult

Family Practitioners and Internists within our centers provide the highest level of primary and preventive care and chronic disease management to our patients, including treatment for asthma, diabetes, hypertension, heart disease, and bronchitis and emphysema. During 2010, we had 49,745 patient visits to our Family Practitioners and 21,739 Internists encounters.

Pediatric

Pediatric services are provided at the Apopka, Eatonville, Leesburg, Pine Hills, South Lake, and Winter Garden Pediatric Care Centers. Full comprehensive care is provided, including vaccinations, physical exams, vision and hearing screenings, and treatment of childhood chronic illnesses, accidents and injuries. *There were* 44,523 pediatric patient visits during 2010.

Obstetrics & Gynecology

OB/Gyn services include prenatal and postpartum care, high risk care, deliveries, gynecological care and surgery, patient education, family planning counseling and case management services at our Apopka, Leesburg, Pine Hills and Winter Garden Care Centers. We had 13,394 OB/Gyn visits during 2010, with 1,861 prenatal patients and 956 babies born.

Dental

Our six dental sites are located in the Apopka, Eatonville, Lake Ellenor, Pine Hills, South Lake, and Winter Garden Care Centers. Services include comprehensive adult and pediatric dentistry, preventive oral health education, emergency services for pain and infection, basic restorative procedures, endodontics, extractions, fillings, crowns, fixed and removable prosthodontics, periodontal services, and X-rays. *9,509 patients received dental care in 2010.*

Pharmacy

Pharmacy services are available to our patients within our Apopka, Pine Hills, South Lake and Winter Garden Centers. We participate in Pfizer's Sharing the Care Program and other Patient Assistance Programs (PAP) which enable us to provide prescription drugs at a nominal fee to our patients. We dispensed 16,101 PAP prescriptions in 2010, with a 340B cost basis of \$924,373 and dispensed at no charge 9,452 prescriptions under a Title X Family Planning Services Program. 111,776 prescriptions were filled in 2010.


