Our Optometry Services Provide More than a Vision Check-up

"A couple of months ago a 14-year-old girl entered our center who was experiencing decreasing vision over the past two weeks. She was unable to see anything out of her right eye, and could barely see out of her left eye. After checking the health of her eyes, I found that she had Optic Neuritis, an inflammation that damages the optic nerve in both eyes, as well as a mass in the back of her left eye. Because of the urgency of this diagnosis and our strong relationships with specialists in the community, we were able to refer her immediately to a pediatric ophthalmologist. The mass was caused by a parasitic infection in her left eye. The patient was also diagnosed with an Acute Disseminated Encephalomyelitis, a fast and intense disease that could have led to paralysis or neurological deficits. After treatment, her vision in her right eye has improved to the point where she is no longer considered legally blind, and her vision will continue to improve with treatment."

A Letter from a Parent

At the end of each appointment, we thank our parents for bringing their child to Community Health Centers. Recently, a mother of one of our dental patients said, "Thank you for saying that, rarely do people thank me before I thank them." At Community Health Centers, we are grateful that you have chosen us for either your or your children's healthcare needs.

The mother mentioned that she used to feel embarrassed taking her child to another dentist office because her daughter had cavities. She felt like it was her fault which made her reluctant to bring her daughter to the dentist at all. "I didn't know why she had cavities since she brushes her teeth and rarely drinks soda or eats candy," said mom.

At Community Health Centers, our dental team works with our parents and their children on understanding good oral hygiene, as well as, nutrition counseling. "They taught me about cavities and the causes and helped me understand prevention. I had no idea that I could help prevent my daughter's cavities. After a careful review of oral hygiene techniques, they taught us how to properly brush her teeth. That is when I realized that we were brushing her teeth wrong," states mom.

The mother and daughter were so happy with the care that our dental team provided, that she now comes to us for her Pediatric care too.


